Your February study track spans 6 semesters and still gives you the chance to graduate within **3 years**. Since all courses are offered in both semesters, we have put together a standard February track which you can find in the following pages.

It is possible to **request exemptions** so that your study track is customized. Would you like to discuss your track in advance? Then be sure to contact the Student Community Coach of the programme (karel.cappelle@artefveldehs.be).

3 steps for a smooth start

STEP 1: Online enrolment and free language screening

Enrol online, before March 1, via the following link:
www.artefvelde-uas.be/enrolment

- You will have to prove your level of English with a language certificate. Or you can opt for a free language screening test organised by Artevelde University of Applied Sciences.
- Have you obtained credits elsewhere and do you want to request exemptions? Submit your request after your enrolment (see step 2).
- Do you want to discuss your study track? Send an e-mail to the Student Community Coach: studyprogrammeibm@artefveldehs.be

To finalize your enrolment online, you have to digitally sign your study track in the final step.

You will receive an e-mail with your login and password via the central student administration and an invitation to pay your tuition fees. Your student card will be sent by post to your home address.

STEP 2: Request exemptions

Students who have already obtained credits elsewhere can apply for exemptions via the student platform My Dinar. Log in with the information you received via the central student administration. Go to 'Digital Administration Office' and choose 'Exemption application module'. Complete the steps to request your exemptions.

STEP 3: Prepare your start

On My Dinar you can find, as from the day you enrol, a lot of essential information. Be sure to check the Welcome platform for new students for more tips and tricks for a smooth start.

FAQ

1. When do classes start?

Semester 2 (and classes) start on Monday, February 12.

2. How and until when can I enrol?

You register online via the website. Registration is possible until 1 March but it is best to register as soon as possible. That way you will miss as few lessons as possible.

3. Which courses may and can I follow?

If you don't request exemptions, your study track is as shown on the following page. If your study track needs to be adapted due to exemptions or personal reasons, your Student Community Coach will put together a personal study track with you.

4. Can I request exemptions?

Students who have already obtained credits elsewhere can apply for exemptions via the student platform My Dinar. Log in with the information you received via the central student administration. Go to 'Digital Administration Office' and choose 'Exemption application module'. Complete the steps to request your exemptions

5. What about all practical matters such as study books?

After your enrolment you will receive a login and password for the student portal (My Dinar). Be sure to check the Welcome platform. It contains all the information for a smooth start. For example: timetable, class group, purchasing books, etc.

6. If we start in February, will we join existing class groups?

Yes, students who start in February are not in separate groups. You will follow the lessons with students who started in September.

7. What if you don't pass the language screening? Can I use any language certificate to prove my level?

If you fail the language screening, there are other ways to prove you meet the required language level (B2 - CEFR). Check our website for all certificates that are accepted.

Did you know that ...

... those who change programmes in the first year of higher education will receive half of the taken credits back for the course units for which no exams were taken.

... credit certificates obtained at Flemish institutions are automatically included in the exemption application module. You can upload other credit certificates yourself in the system.
